Saint Francis County Sheriff vs T-Gard Bail Bonding/Yolonda Riley

Todd Gardner Owner of T-Gard was present, along with Yolonda Riley. Board heard evidence. Judgment as follows.

Based on the substantial evidence in the record, the Arkansas Professional Bail Bond Company and Professional Bail Bond Licensing Board hereby orders:

The license of Respondent Riley shall be suspended for thirty (30) days. As Respondent Riley is not currently employed as an agent by any licensed bonding company, the imposition of this suspension will not begin until she becomes employed by another licensed bonding company. No adverse finding or penalty is imposed on Respondent T-Guard Bail Bonding.

Pursuant to Ark. Code Ann. § 25-15-212 and § 17-19-210(i), Respondent Riley may appeal the Board's decision by filing a petition for judicial review in the Circuit Court of Pulaski County within thirty (30) days of the date on the certificate of service attached to this Order. Motion was made by Edwards and seconded by Joyner. Motion passed. Motion was made by Clark not to seek action against T-Gard Bail Bonding, Joyner seconded. Motion passed.

Pulaski County Circuit Court vs John Chism Bail Bonds/Kory Kelley/James Kelley/Andrew Perry. Lonoke County Circuit Court vs John Chism Bail Bonds/Akee Jamal Johnson/Christen Warren/Michelle Castleberry/ Christopher Brown/Danny Proffitt Jr... Benton County Circuit Court vs John Chism Bail Bonds\Amy Figueroa.

The board orders the director and AG to send out appropriate letters to John Chism Bail Bonds and the bank that holds the letter of credit for John Chism Bail Bond to have the above listed forfeitures paid. If unable to collect on letter of credit, pay using the Bail Bond Forfeiture Fund. Motion was made Clark and seconded by Person. Motion passed.
