ARKANSAS PROFESSIONAL BAIL BONDSMAN LICENSING BOARD

Regular Meeting via Zoom February 11, 2022

Chairman Curt Clark called the meeting to order.

Roll call was taken. The following members were present Molder, Wilburn, Clark, Muldoon, Edwards Joyner, and Linda Craig was present.

Assistant Attorney General Joe West was present. Board Staff was present.

Minutes presented for previous meeting were approved. Edwards made motion to approve previous minutes Wilburn seconded. Motion passed.

Hearings

Benton County Circuit Court vs Triple R Bail Bonds, Inc\Eric Long Forfeiture Hearing.

On the December 10th, 2021, board meeting Triple R Bail Bonds, Inc. was granted a 60-day extension to get the ordered forfeiture by Benton County Circuit Court set aside. On this date Triple R Bail Bonds, Inc. owner Jeremy Roland was present and represented by his attorney Dan Hancock. After hearing testimony by the state witness, defense witnesses and being told by the defense that the Judge from Benton County Circuit Court had not set aside the judgement, the board went into discussion of the facts. A motion was made by Edwards that Triple R Bail Bonds, Inc. has until Wednesday February 16, 2022, by end of the day to provide proof the forfeiture judgement payment and if receipt of payment is not provided by such time listed, the company license will be suspended until such time payment is made and receipt is provided. Wilburn seconded the motion. Clark called for a role call vote on the motion. Vote- Molder Yes, Wilburn Yes, Clark Yes, Muldoon Yes, Edwards Yes, Joyner No, Craig Yes. Motion passed with a vote of 6 Yes, 1 No.

Lonoke Circuit Court vs John Chism Bail Bonds Forfeiture Hearing

No one from John Chism Bail Bonds was present for hearing. The AG office present testimony form the state witness. After a brief discussion. Edwards made a motion to pay outstanding forfeitures on John Chism Bail Bonds from the bail bond recovery fund and continue trying to collect on the company's letter of credit. Buck seconded. Motion passed.

A request of notice by the board to have Susan Townsend of Donna's Bail Bond and was previously an agent of John Chism Bail Bonds who wrote 7-8 of the outstanding bond that are up for forfeiture attend the March 11, 2022 board meeting to answer questions.
