## APBBLB vs Niki Charles and Lynda Craig License Revocation

Lynda Charles present in person, Niki Charles present via Zoom. Lynda and Niki Charles of Free at Last Bail Bonds was not represented by counsel. APBBLB was represented by Assistant Attorney General Doug House.

After hearing facts from Assistant Attorney General Doug House and hearing testimony from the defendants, based on the evidence giving by both sides.
